Table Covering: linens will be provided. You will need to pick up and return the linens to the information table.

Demonstrations: all demonstrations are welcome and will be put on stage or highlighted on our flyers; however, you must notify the committee to be listed on the flyers by April 1st. Please contact **Tulrich @pawccd.org** with any questions.

Service Animals: are permitted at Ag Days with the proper credentials. Please stop at the information table to register, which will allow you to enter buildings.
